- Direct supervision/management of all Maintenance personnel and outside contractors.
- Co-ordinate/prioritize all Maintenance personnel and activities as per PM schedules and production priorities.
- Design, implement and maintain measures for a complete prevention program/schedule for all production equipment and facilities including developing daily, weekly, monthly and annual checklists for all production equipment and facility items, and ensuring the checklists are completed on a timely basis.
- Create an overall preventive maintenance board showing all current completed and past due preventive maintenance checks on all production equipment and facility items.
- Design, implement and maintain for all production equipment and facility a maintenance work order system.
- Lead, support, participate, and develop schedules and procedures for a total preventive maintenance program.
- Direct the maintenance and repair of machinery, equipment and electrical and mechanical systems.
- Manage a maintenance budget.
- Negotiate with suppliers in administering contracts for supplies and services.
- Assist Maintenance personnel to resolve equipment maintenance issues with minimal disruption to production, including working with other Production departments to decide when and if to shut down the equipment.

- Review current OEE information to set priorities for equipment overhaul to reduce downtime and/or rejections.
- Responsible for ensuring proper upkeep of Maintenance cribs and ordering and using spares in the most efficient manner to reduce maintenance costs.
- Develop a critical spare parts list for all production equipment and facility items outlining the item, supplier, cost and delivery of each item to be used.
- Order and stock critical spare parts after approval received from Management.
- Design and recommend modifications to current equipment to decrease downtime and increase quality.
- Participate in design and review of new equipment to ensure it meets legislative and internal standards.
- Adhere to and ensure all team members follow company lockout/tag out policies and procedures when performing any type of maintenance work/repairs on production equipment.
- Adhere to and ensure all obligations and requirements under Sections 25-28 of the Occupational Health and Safety Act are met.
- Adhere to and ensure all employer obligations and duties outlined in the Workplace Safety and Insurance Act are met.
- Ensure all department team members work in compliance with IATF-16949, and all other company policies and procedures.
- Co-ordinate with Human Resources Generalist all training, performance reviews, discipline, hiring and termination actions within your department.
- Prepare, propose, and justify department budget and expenses.
- Ensure team measurable are submitted in a timely manner and appropriate across plant.
- Ensure production (whether raw materials or services), maintenance, and tooling items are purchased according to company policy.
